ORDER

Pursuant to Title 28, United States Code, Section 631(a) and in accordance with actions taken by the Judicial Conference of the United States September 20, 1993,

It is ORDERED that the full-time magistrate judges at Knoxville, Chattanooga, and Greeneville in the Eastern District of Tennessee are authorized to serve in the adjoining Western District of Virginia and in the Eastern District of Kentucky, and

The full-time magistrate judge at Abingdon in the Western District of Virginia is authorized to serve in the adjoining Eastern District of Tennessee and in the Eastern District of Kentucky, and

The full-time magistrate judge at Lexington in the Eastern District of Kentucky is authorized to serve in the adjoining Eastern District of Tennessee and in the Western District of Virginia,

This authorization being given for the purpose of carrying out the duties specified in Title 28, United States Code, Section 636(a) and Title 18, United States Code, Section 3401, to the extent that such duties are exercised in connection with matters arising in the Cumberland Gap National Historical Park.
