**STANDING ORDER 2021-22**

At its September 2021 meeting, the Judicial Conference of the United States amended the court reporter transcript fee schedule to simplify the billing process for realtime court reporting. Accordingly, it is

**ORDERED** that the maximum transcript fee rates set forth in Attachment 1 are adopted as the appropriate fees to be charged for the production and delivery of transcripts by court reporters in this District. The amended transcript fee rates shall be effective immediately and remain in place until such time as the Judicial Conference authorizes a rate change.

This Standing Order supersedes all other prior standing orders regarding transcript fee rates.

The clerk is directed to enter this order in the orders books for each division.

<p><b>Ordinary Transcript (30 day)</b> A transcript to be delivered within thirty (30) calendar days after receipt of an order.</p>	\$3.65	\$.90	\$.60

<p><b>3-Day Transcript</b> A transcript to be delivered within three (3) calendar days after receipt of an order.</p>	\$5.45	\$1.05	\$.75
<p><b>Daily Transcript</b> A transcript to be delivered on the calendar day following receipt of the order (regardless of whether that calendar day is a weekend or holiday), prior to the normal opening hour of the clerk’s office.</p>	\$6.05	\$1.20	\$.90
<p><b>Hourly Transcript</b> A transcript of proceedings to be delivered within two (2) hours from receipt of the order.</p>	\$7.25	\$1.20	\$.90
<p><b>Realtime Transcript</b> A draft unedited transcript produced by a certified realtime reporter as a byproduct of realtime to be delivered electronically during proceedings or immediately following receipt of the order.</p>	<p>One feed, \$3.05 per page; two-to-four feeds, \$2.10 per page; five or more feeds, \$1.50 per page.</p> <p>Orders placed on or before the day of the proceeding will be batched together for purposes of determining the number of feeds; and subsequent orders will be charged at the lowest page rate assessed on the previous orders.</p>	N/A	N/A
