The court has received a report from the Criminal Justice Act (CJA) Advisory Committee recommending CJA attorney panel appointments. Inasmuch as the judges of the court have met to consider the Committee's recommendations, it is now

ORDERED

as follows:

- 1. The Committee recommendations are adopted in part;
- 2. Effective July 1, 2014, the CJA panels for the Abingdon and Big Stone Gap divisions of the court are consolidated, and the CJA panels for the Danville and Lynchburg divisions of the court are consolidated. Each division, however, will continue to maintain its own individual representative on the CJA Advisory Committee;
- 3. The Advisory Committee Internal Operational Guidelines shall be, and hereby are, AMENDED so as to add, at the appropriate point in the Guidelines, the following modification:

For the purpose of attorney appointments, effective July 1, 2014, the Court has determined that consolidation of the panels for the Abingdon and Big Stone Gap divisions and consolidation of the panels for the Danville and Lynchburg divisions are necessary in order to ensure an equitable distribution of case assignments. The court will continue to appoint a panel attorney from each division to represent the division on the CJA Advisory Committee as set forth above.

4. Effective July 1, 2014, the division panels shall be, and hereby are, modified so as to reflect the following attorney additions in place of those attorneys rotating off each division panel:
