RESTRICTIONS ON VISITORS TO COURTHOUSES

Standing Order No. 2020-4

The United States District Court for the Western District of Virginia is closely monitoring the pandemic of the coronavirus known as COVID-19 as well as the guidance issued by the Centers for Disease Control and Prevention (CDC) and the World Health Organization (WHO). The CDC has advised precautionary measures, emphasized the importance of containing the outbreak, and noted that the best way to prevent illness is to avoid being exposed to the virus. To help stem the tide of this pandemic and to protect the court, its employees, and the public, it is **ORDERED** as follows:

- 1. The following persons shall not enter any U.S. Courthouse or U.S. Probation Office in the Western District of Virginia without prior permission from the Chief Judge:
  - Persons who have been in any of the following countries or regions within the last 14 days:

CHINA SOUTH KOREA JAPAN ITALY IRAN

- Persons who reside or have had close contact with someone who has been in one of the countries or regions listed above within the last 14 days;
- Persons who have been asked to self-quarantine by any doctor, hospital, or health agency;
- Persons who have been diagnosed with, or have had contact with anyone who has

been diagnosed with COVID-19 within the past 14 days;

- 2. The United States Marshal, his Deputies, and the Court Security Officers shall deny entry to anyone attempting to enter a U.S. Courthouse or U.S. Probation Office in the Western District of Virginia in violation of this Order;
- 3. If you are scheduled or required to appear at a U.S. Courthouse or U.S. Probation Office in the Western District of Virginia, and you are unable to appear because of the restrictions in this Order, you are directed to proceed as follows:
  - If you are represented by an attorney, please contact your attorney;
  - If you are an attorney and you are scheduled to appear in court before a judge,
     please contact that judge's Courtroom Deputy Clerk or chambers directly;
  - If you are scheduled to meet with a Probation Officer, please contact the

federal court physically, you are directed to contact the Clerk's Office in the appropriate

division to make special filing arrangements.

5. These temporary restrictions will remain in place until it is determined to be safe to

remove them.
