

STANDING ORDER 2023-16

At its September 2022 session, the Judicial Conference of the United States approved an increase to the maximum per page original and copy transcript fee rates for fiscal years 2024 and 2025, effective October 1, 2023. Accordingly, it is

**ORDERED** that the maximum transcript fee rates set forth in Attachment 1 for fiscal year 2024 and Attachment 2 for fiscal year 2025 are adopted as the appropriate fees to be charged for the production and delivery of transcripts by court reporters in this District, effective October 1, 2023, for fiscal year 2024 and October 1, 2024, for fiscal year 2025. The amended transcript fee rates shall remain in place until such time as the Judicial Conference authorizes additional rate changes.

This Standing Order supersedes all other prior standing orders regarding transcript fee rates.

The clerk is directed to enter this order in the orders books for each division.
