) No. 2025-18

The Clerk of Court is directed to implement the random assignment of cases and miscellaneous proceedings as follows:

(1) Abingdon Division. All cases and miscellaneous proceedings are to be assigned on rotation in the following manner:

- a. All civil cases and miscellaneous civil proceedings are to be assigned to Senior Judge James P. Jones.
- b. All criminal cases and miscellaneous criminal proceedings: one case to Judge Thomas T. Cullen and one case to Judge Robert S. Ballou.

(2) Charlottesville Division. All cases and miscellaneous proceedings are to be assigned to Judge Jasmine H. Yoon.

(3) Harrisonburg Division. All cases and miscellaneous proceedings are to be assigned on rotation in the following manner:

- a. All civil cases and miscellaneous civil proceedings: one case to Chief Judge Elizabeth K. Dillon, one case to Judge Thomas T. Cullen, and one case to Judge Jasmine H. Yoon.

b. All criminal cases and miscellaneous criminal proceedings are assigned to Judge
Jasmine H. Yoon.

(4) Lynchburg Division. All cases and miscellaneous proceedings are to be assigned on rotation in the following manner:

- a. All civil cases and miscellaneous civil proceedings: one case to Senior Judge Norman K. Moon and one case to Judge Robert S. Ballou.
- b. All criminal cases and miscellaneous criminal proceedings: one case to Senior Judge Norman K. Moon and one case to Judge Thomas T. Cullen.

(5) Roanoke Division. All cases and miscellaneous proceedings are to be assigned on rotation in the following manner:

- a. All prisoner cases, as defined by separate Standing Order of the Court: one case to Senior Judge James P. Jones, one case to Senior Judge Michael F. Urbanski, one case to Chief Judge Elizabeth Dillon, one case to Judge Thomas T. Cullen, one case to Judge Robert S. Ballou, and one case to Judge Jasmine H. Yoon.
- b. All civil cases: one case to Chief Judge Elizabeth K. Dillon, one case to Judge Thomas T. Cullen, and one case to Judge Robert S. Ballou.
- c. All miscellaneous civil proceedings: one case to Senior Judge Michael F. Urbanski, one case to Chief Judge Elizabeth K. Dillon, one case to Judge Thomas T. Cullen, and one case to Judge Robert S. Ballou.
- d. All criminal cases and miscellaneous criminal proceedings: one case to Chief Judge Elizabeth K. Dillon, one case to Judge Thomas T. Cullen, and one case to Judge Robert S. Ballou.

(6) Capital Cases. Criminal cases in which one or more of the defendants is eligible for the death penalty are to be assigned to the active district judges in the rotation of criminal cases for the division in which the case arises. If there is more than one active district judge in the rotation of criminal cases for that division, the case is to be assigned to the

active district judge next in rotation who is not currently assigned a capital case, or who is currently assigned the least number of capital cases. If there is no active judge in the rotation for the division, the case is to be assigned to an active district judge by the Chief Judge, taking into account the desire to balance capital cases among the active district judges. Habeas cases in which the petitioner is under sentence of death are to be assigned to the active district judges in the district in rotation by order of seniority, regardless of the division in which the case arose.

(7) Miscellaneous—Case Conflicts and Related Cases.

- a. Conflicts. Assignment of cases in which a judge has a conflict will be made in the following manner.
 - i. Abingdon. Judge Robert S. Ballou will be assigned civil cases in which Senior Judge James P. Jones has a conflict. Regarding criminal cases, in the event a judge has a conflict in a case that would have been assigned to him/her under the rotation, the Clerk shall assign that case to the next judge in the rotation without a conflict and shall assign the disqualified judge two cases when he/she is next in the rotation.
 - ii. Charlottesville. Senior Judge Norman K. Moon will be assigned civil cases in which Judge Jasmine H. Yoon has a conflict. Judge Thomas T. Cullen will be assigned criminal cases in which Judge Jasmine H. Yoon has a conflict.
 - iii. Harrisonburg. In the event a judge has a conflict in a civil case or miscellaneous proceeding that would have been assigned him/her under the rotation, the Clerk shall assign that case to the next judge in the rotation without a conflict and shall assign the disqualified judge two cases when

he/she is next in the rotation. Regarding criminal cases in which Judge Jasmine H. Yoon has a conflict, the Clerk shall rotate assignments one case to Chief Judge Elizabeth K. Dillon and one case to Judge Thomas T. Cullen.

- iv. Lynchburg. In the event a judge has a conflict in a case or miscellaneous proceeding that would have been assigned him/her under the rotation, the Clerk shall assign that case to the next judge in the rotation without a conflict and shall assign the disqualified judge two cases when he/she is next in the rotation.
- v. Roanoke. In the event a judge has a conflict in a case or miscellaneous proceeding that would have been assigned him/her under the rotation, the Clerk shall assign that case to the next judge in the rotation without a conflict and shall assign the disqualified judge two cases when he/she is next in the rotation.
- vi. Chief Judge. If all judges assigned to a division have a conflict or are unable to hear a given case, the Chief Judge will assign the case.

- b. Related Cases. The Clerk shall assign a new case or miscellaneous proceeding that is related to a pending case or miscellaneous proceeding within the division to the district judge before whom the related case or miscellaneous proceeding is pending, and in the event of multiple related filings (five or more related cases), shall obtain the guidance of the judges within the division before making the assignment and determining its effect on the rotation within the division.

(8) Nothing in this order shall be construed to prevent any district judge from relinquishing any case on his/her docket or from reassigning any case on his/her docket to a judge in a rotation

in that division with the consent of the judge to whom the case is reassigned. When a judge reassigned a case to another judge, an order will be entered transferring that case to the second judge's docket. If the assignment is for a limited purpose, the order shall state the limits of the second judge's involvement, so that the Clerk's Office and parties are fully informed.

(9) This Standing Order supersedes all prior case assignment orders and memoranda of this Court and shall take effect on Monday, January 5, 2026.
