Upon the motion of the United States Attorney, SCHEDULE C attached to the Order of this Court dated April 7, 1998, governing procedure in petty offense cases – RULE 58 FORFEITURES OF COLLATERAL IN LIEU OF APPEARANCE IN PETTY OFFENSE CASES – is updated to amend the entire forfeiture schedule for the United States Department of the Army, Corps of Engineers.

The attached SCHEDULE C is effective June 15, 2005, and will replace SCHEDULE C dated April 1, 2000, filed with the Forfeiture of Collateral Schedule.
